### 1 Introduction

The Software Defined Radio Forum, Inc. doing business as the Wireless Innovation Forum is an international group of equipment vendors, subsystem vendors, software developers, technology developers, communication service providers, research and engineering organizations, academic institutions, government users, regulators and other interested parties who share the common business interests of advancing technologies supporting the innovative utilization of spectrum and the development of wireless communications systems, including essential or critical communications systems<sup>1</sup>.

Within the Wireless Innovation Forum, the Spectrum Sharing Committee serves as a common industry and government standards body to support the development and advancement of spectrum sharing technologies based on the three-tier architecture proposed for the Citizens Broadband Radio Service (FCC Part 96) rulemaking activities<sup>2</sup>. - a. CAs shall contact the auditor directly, and shall enter into such agreement and pay such price as the auditor shall determine.
- b. The auditor shall submit an audit report to WInnForum using an approved form provided by WInnForum for that purpose.
- c. A completed report shall state that the applicant CA had met the accreditation criteria, and shall include substantiating data.
- d. WInnForum shall review the report to confirm that the accreditation criteria had been met.
